

WHIRL-Y-FAYRE 2015

TERMS & CONDITIONS

1. No refunds other than on cancellation or substantial alteration of the event (or due to point 5 below). Refunds should be claimed from the point of purchase no later than three months from the last day of the event. The face value of the ticket will be refunded.
2. E-Tickets must be exchanged for a wristband on entry at the pass office. The E ticket must be validated at the pass office by producing the last 4 digits from the payment card. There will be no re-admission. E-Tickets are non-transferable. You are responsible for your E-Ticket until it is exchanged for a wristband. Whirl-y-Fayre will not issue duplicate tickets for lost or stolen tickets. All wristbands remain the property of Whirl-y-Fayre until midnight of the last day of the event.
3. E-Tickets are only valid when purchased from Whirl-y-Fayre. Any tickets bought from other sources will be refused admission.
4. Entry will only be permitted on production of valid E-Tickets only. An E-Ticket will be sent as an attachment on a separate email after your order confirmation e-mail. On-line Bookings can only be made by persons over 18 years. Whirl-y-Gig operates a strict no-refund policy other than the cancellation of the event. Payments made on this site will appear as "Field of Fun Internet"
5. All E-Tickets must be paid for at full face-value, ie adult ticket or child concession ticket. Parents will be required to show proof of age (Birth Certificate only) when exchanging child E-Tickets for wristbands.
6. No unaccompanied under 16 year olds are allowed on site. Under 16's must be accompanied by a parent.
7. For the safety, security and comfort of all participants, Whirl-y-Fayre reserves the right to evict without refund or to refuse admission having refunded the ticket face value.
8. Artists may be subject to change due to circumstances beyond our control.
9. Whirl-y-Fayre is unable to accept liability for personal damages, losses or injuries sustained at this event, including damage and losses to property and motor vehicles.
10. Strictly no unofficial trading allowed anywhere on the Whirl-y-Fayre site.
11. You give your express consent to your actual or simulated likeness to be included for no fee within any film, photograph, audio and/or audio-visual recording to be exploited in any and all media for any purpose at any time throughout the world. This could include filming by the police or security staff which may be carried out for the security of customers or the prevention of crime.
12. Please use the litter bins and recycling points provided on site. Please do not drop litter on the way to and from the venue.
13. No unauthorised buses, coaches or trucks will be allowed on site.
14. The following items are not permitted anywhere on site: Glass, Illegal Substances, or legal highs, Nitrous Oxide, Portable Laser Equipment and Pens, Unauthorised Professional Film or Video Equipment, Audio Recorders, and no sound systems of any kind, Sky Lanterns, Megaphones, Unofficial Tabards or Reflective Jackets, Air Horns, Spray Cans, Fireworks, Sparklers and Flares, Unauthorised items for trading, including any goods using unauthorised event logos. All items will be confiscated (not returned). Generators and large camping gas canisters are not allowed on site (exception for those fixed within campervans).
15. You may be searched at the entrance to the Main Arena. Any item(s), which may reasonably be considered for use as a weapon, or which may cause danger or disruption to any other persons at the event, will be confiscated. Persons suspected of carrying items that may be used in an offensive or dangerous manner, or carrying out illegal activities within the arena or other parts of the site may be searched.
16. Under 18s are not permitted to purchase alcohol on site. Similarly, it is illegal for anyone over the age of 18 to purchase alcohol on behalf of anyone under 18
17. The following items may not be brought in to the Main Arena: Alcohol, bottles or cans, camping equipment, disposable barbecues. Food and drink (but not alcohol) for personal consumption may be brought in to the main arena.
18. No animals other than registered guide or hearing dogs are permitted on site.
19. Ground fires are not permitted anywhere on site except in the designated Fire Pit Enclosure. Raised caldron fires and barbecues are permitted in the campsite providing there is absolutely no residue on the land whatsoever. Burning of plastics is not permitted anywhere on site.
20. Smoking is not permitted in enclosed public spaces including main arena big tops.
21. Anyone found with any drugs, including legal highs, will be refused entry to the event.
22. Pass-outs will not be permitted in order to minimize disturbance in what is an idyllically quiet local area. In exceptional circumstances or in an emergency, please enquire at the Pass Office for a pass-out by special arrangement.
